MEMORANDUM OF UNDERSTANDING

Kunwar Shekhar Vijendra Ayurveda Medical College and Research Centre, Gangoh, Saharanpur (U.P.)

1. Parties to the Agreement

This Memorandum of Understanding (MoU) is entered into by and between:

- Jay Hind Samajik Sanstha, Mohallah Chatta, Gangoh, Saharanpur (U.P.), is an NGO registered under 12A/80G under income tax act, with registration No. 66/2023,
- Kunwar Shekhar Vijendra Ayurved Medical College and Research Centre (KSVAMC&RC), a constituent institution of Shobhit University, Gangoh, Saharanpur, Uttar Pradesh, established in 2014 and recognized by the National Commission for Indian System of Medicine (NCISM), Ministry of AYUSH, Government of India.

2. Purpose

The purpose of this MoU is to establish a collaborative framework between Jay Hind Samajik Sanstha and KSVAMC&RC to:

- To serve the rural society and promote Health and Wellbeing.

3. Areas of Collaboration

The collaboration shall encompass, but not be limited to, the following areas:

- 3.1 Sharing of the resources for the welfare of society and neighbourhood community.
- 3.2 Organization of awareness programs related to healthy, general well-being, cleanliness and organ donation.
- 3.3 Organization of Blood donation camps, health camps.
- 3.4 Any other such area of mutual interest.

4. Implementation and Governance

- A Joint Coordination Committee (JCC) comprising representatives from both, Jay Hind Samajik Sanstha and KSVAMC&RC shall be established to oversee the implementation of this MoU.
- The JCC shall meet bi-annually to review progress, set priorities, and plan future activities.

5. Duration and Termination

- This MoU shall remain in effect for a period of five (5) years from the date of signing.
- Either party may terminate this MoU by providing three (3) months written notice to the other party.
- Termination shall not affect ongoing projects, which shall continue as per agreed terms.

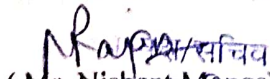
6. Confidentiality
